Motion to Approve Previous Meeting Minutes

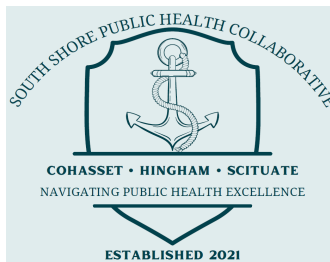
Andrew Scheele motioned to approve the October 16th meeting minutes.

Coalition Updates**MOU for Fuel Assistance through SSCAC**

SSPHC's Regional Social Workers will be helping residents sign up for fuel assistance through the South Shore Community Action Council (SSCAC) this fall and winter. The SSCAC has asked that SSPHC sign an MOU to confirm the coalition's partnership in this work. BME Strategies confirmed with representatives at the Massachusetts Association of Health Boards (MAHB) that Cohasset is responsible for signing this MOU as outlined in the coalition's Inter-Municipal Agreement (IMA). Joan Taverna will confirm with town management in Cohasset who specifically should sign the MOU.

Hoarding Disorder Program

Vote on format and approval of Hoarding Disorder Book Discussion Group

The coalition discussed various reasons for choosing between two group discussion options. Ultimately, the coalition decided to move forward with the Buried in Treasures book discussion group. However, the group is not yet able to sign the contract with Suzanne Otte from BU School of Social Work. The coalition will need to confirm who in Cohasset would be responsible for signing this contract and confirm whether there are any additional procedures that it must adhere to given that the total cost for the Hoarding Disorder programming exceeds \$10,000. The coalition provided provisional approval to move forward with this contract pending approval from Cohasset.

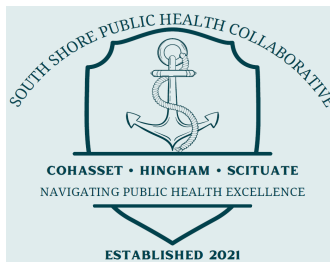
Discussion of FY26 Budget and Staffing

The coalition discussed how to ensure that regional staff are being engaged most efficiently and that their time is being used most productively. The coalition reviewed the job description for the regional public health nurse role and discussed the extent to which the current regional public health nurse duties are being fulfilled. There is potential to re-allocate some funding under the regional public health line item to other line items in the budget based on how many hours are billed to public health nursing for the remainder of FY26.

The coalition may consider engaging with a Local Public Health Nurse Consultant who can provide subject matter expertise about the potential scope of public health nursing activities across SSPHC's three municipalities.

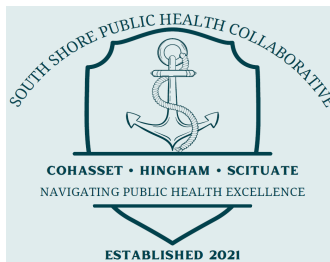
